CONTINUED STRONG ORGANIC GROWTH

Q3 SUMMARY

- Continued trend on good price achievement in period.
 - Market prices lower compared to the highs of Q2.
 - Most of volume late in quarter at lower market price.
- General raw material price-increases, and low volumes in beginning of quarter, result in some increased cost.
 - Continued stable biological performance but re-evaluation of biological stock had an impact on our operational EBIT by 0,52 EUR/kg.
 - Harvest of 2020 generation in Q3 with high average weight, and superior share.
- Expect increased volume and stable cost levels in Q4 2022
 - 2020 generation finalized in Q4 and start on 2021 generation
 - Continue with high average weight and expect high superior share
- Growth plans developing according to plan
 - Ísþór smolt plan acquired and full integration into the Arnarlax family is under way.
 - Expect stable demand for Atlantic Salmon from Iceland
- Volume guidance at 16.000 tonnes for 2022, and expect same level for 2023
 - Expect significant increase in 2024 following the investments in smolt capacity in 2021/22



- With sufficient capacity on smolt production, smolt size could be adapted to optimized MAB utilization



FOCUS ON ACTIVE COMUNICATION WITH CUSTOMERS

- Participation in Seafood shows and customer visit in the quarter.
 - Positive feedback from customers on product quality.
 - Several new customers with increased interest from European customers and good demand from US both by ship and flight.

CONTRACTS

Contract share for Q3 was 17% and is expected to be ~22%, for Q4 2022.

- Continued emphasis on sea transport to the US market
 - Volume to US, quarter by quarter continues to grow.
 - Icelandic logistics routes offer perhaps the lowest carbon footprint salmon imported to North America.

 - Getting us closer to the end consumer and representing an important step in building the Arnarlax brand.









LICENSE STATUS FOR SEA-WATER STRATEGIC UPDATE AND OUTLOOK

FOSSFJÖRÐUR RENEWED*

Our license in Fossfjörður was renewed during Q3. MAB is now 1.500t.

The management believes the MAB should have been renewed at 3.000t and is preparing an appeal.

Additionally, preparations ongoing regarding merging Fossfjörður with the bigger Arnarfjörður license.

NEW SITES WITHIN EXISTING LICENCES

Currently in process to establish more sites for better MAB utilisation.

First site has been issued in Patreksfjörður and Expansion of current sites in Arnarfjörður in application progress.

ÍSAFJÖRÐUR LICENSE STATUS

Application for a farming license in Ísafjarðardjúp is still in process

Arnarlax is in a position to receive a license for **10,000** tonnes in Ísafjarðardjúp despite uncertainty on the share of fertile fish


Expected to be issued late 2022 or Q1 2023

ARNARFJÖRÐUR EXPANSION

The Arnarlax application for increased biomass in Arnarfjörður of 4,500 tonnes has not been processed and the application process has been delayed.


Work on an updated application is in progress according to new Aquaculture law.

The exact timeline of the application process is still undetermined.

KEY ITEMS FOR THIRD QUARTER 2022

- Acquisition of remaining 50% shares of smolt facility Eldisstöðin Ísþór
- Increase of fixed assets EUR 29.2 million and Net interest-bearing debts EUR 24.3 million within quarter
- Secured further access to capital through bank lines
- Net cash flow from investing activities total EUR 15.0 million in third quarter.

FINANCIAL POSITION

- Assets totaled to EUR 234 million with an increase of EUR 37 million in quarter mainly due to acquisition of smolt facility Eldisstöðin Ísþór.
 - Other Investment within quarter EUR 4.4 million
 - Other Investment within year EUR 11.5 million.
- Total equity EUR 142.8 million, up by EUR 13.1 million in quarter.
